



Orlando Rowing Club Waiver Form

In consideration of being given the opportunity to participate in the **Orlando Rowing Club, referred to as ORC**, I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. I ACKNOWLEDGE, agree, and represent that I understand the nature of rowing activities, both on the water and land based and that I am qualified, in good health, and in proper physical condition to participate.

2. I FULLY UNDERSTAND that:

- ROWING ACTIVITIES INVOLVE RISKS AND DANGERS of serious bodily injury, including permanent disability, paralysis, and death ("risks");
- these risks may be caused by my own actions, or inactions, the actions of others participating in the Regatta, the conditions in which the Regatta takes place, or the negligence of the "releasees" named below;
- there may be other risks and social and economic losses either not known to me or not foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Orlando Rowing Club.
- The Orlando Rowing Club will not be held responsible or liable for any loss or damage to any equipment owned or leased by club members. It shall be the members responsibility to provide adequate insurance to cover equipment in the event of loss or damage. Members storing and/or using privately owned or leased equipment shall be liable for any and all damages incurred as a result of moving equipment around, into and out of the boathouse, the Orlando Rowing Club's property, the Property of the City of Orlando and all related damage or accidents while in the act of rowing.

3. I AGREE AND WARRANT that I shall be cautious and make every effort to safely move equipment between the boathouse, city property and lake fairview and report to the boathouse director any damage created by myself to my equipment or to Orlando Rowing Clubs equipment or equipment owned by members of the Orlando Rowing Club, Bishop Moore High School, and Lake Brantley Rowing Association.

4. I HEREBY RELEASE, discharge, and covenant not to hold liable nor sue the Orlando Rowing Club, their administrators, directors, agents, officers, volunteers and employees, and other participants, club organizers, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Regatta takes place (each considered one of the releasees herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS each of the releasees from any litigation expenses, attorney fees, loss liability, damages, or costs which they may incur as a the result of such a claim.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force. If applicant is under the age of 18, a parent or legal guardian must sign this form.
